Annual General Meeting – 2021 Treasurer's report

The 2019/20 season at GHBC has been unique. Never before have we faced such issues and indeed threats to future of our Club. Not least among these was the need to reduce the financial impact on the club of all the reduced activity – no friendly matches, no county leagues or competitions, no club competitions, much reduced bowling activities, and limited bar through the summer. Fortunately our winter season did well financially before the Covid-19 lockdown in March.

And so to the financial results. Income for the year 2019/20 was down by over £14,000 compared with the previous year, mainly as a result of loss of match fees (£4,000), Bar Sales (£6,000) and Subscriptions (£2,000). This was not aided by a decrease in membership from 123 to 107.

Expenditure was reduced by over £24,000, but after discounting the extra-ordinary cost of the kitchen refurbishment in the previous year, it was reduced by around £13,000, mainly due to a discount from BTC on the maintenance of the green (£2,000), a refund of all RCBBA fees (£1,369), reduced bar costs (£4,000), cancellation of Match teas (£1,700), a grant of £1,000 from Barratt Homes and other general savings.

As a result, we made a loss of £167.53 for the year.

This is a truly amazing result after a very difficult year. Thanks are due to those who donated their full bowling subscription to the club, and to those who kept the club going despite all the obstacles.

Thank you also to those who left their subscriptions with the club to reduce the administration involved in paying refunds. We are holding £2,613 in monies which belong to individual members and which will be available to pay future subscriptions.

Thank you to all the members for their patience in working through the various options for paying subscriptions and to those who assisted the Treasurer in keeping track of all the various amounts. If any member is not sure what the club is holding on their behalf, just ask the Treasurer.

Last year we reported that we are using Clubtreasurer.com to maintain the financial records. In the past we have used a simple method of accounting called "Cash accounting". With all the new processes that we needed to introduce and to ensure that members monies were shown separately from the club accounts, the Committee approved a change to "Accruals Accounting". This is more complicated, but much more capable. In the accounts you will see greater reporting of Assets and Liabilities and hopefully this will provide reassurance that we are properly managing the finances.

I have included substantial notes to the accounts and hopefully these will be useful in understanding the figures.

The accounts for the club tour are ably managed by Lorraine Capon and are summarised in the notes. The club tour account was £1,464.12 as at 30^{th} September 2020, unchanged from the previous year. Of this, £1,000 is a club loan. Thanks to Lorraine for maintaining good records for this important aspect of club life.
